1. **Rules:** This regatta will be governed by the *rules* as defined by the current edition of the *Racing Rules of Sailing (RRS)*. This is a category A event.
2. **Eligibility:** All competitors must be current members of the FSSA
3. **Registration** may be by mail using the attached form. It can also be downloaded from the FSSA website or may be completed at the regatta site beginning Friday Oct 8th at 3 PM. *Competitors must choose from either the, Championship, Challenger, or Non-Spinnaker fleets.* A minimum of 5 boats will constitute a fleet and must register by September 25, 2010.
4. Sailing Instructions and Notice of Race will be available to registrants at the completion of registration.

6. **Measurement:** Boats and sails must conform to the Official Plan. Each boat must carry equipment required by FSSA Specification Article S-V.2 (Racing Restrictions), and US Coast Guard requirements. Boats will be randomly checked.
7. **Courses to be Sailed:** The courses to be sailed will be either a *Windward-Leeward* or a *Windward-Leeward-Triangle*. . Courses will be described in the Sailing Instructions.
8. **Scoring:** The low-point scoring system of RRS Appendix A2 will be used, except that all races will be scored. 5 races are scheduled, of which 1 race must be completed to constitute a series.
9. **Prizes:** Prizes will be awarded as follows: Top 5 boats in the Championship Division. Top 5 boats in the Challenger Division. Top 5 boats in the Non - Spinnaker Division assuming the Challenger and non spinnaker fleets meet the requirement above, (item # 3).
