- 1. <u>Rules:</u> This regatta will be governed by the *Rules* as defined by the current edition of the *Racing Rules of Sailing (RRS).*
- Eligibility: The 2015 Flying Scot Greater New York District Championship and Roger Punzi Memorial Regatta is open to all boats of the Flying Scot class whose skippers are eligible members of the Flying Scot Sailing Association Eligible skippers may register by completing the Registration Form and mailing payment to the contact listed below. Check-in and Late Registration will be held between 4:00 and 6:00PM, Friday, August 28<sup>th</sup>, or between 8:30 and 10:00AM Saturday, August 29<sup>th</sup>
- 3. <u>**Registration**</u> may be by mail using the attached form. It can also be downloaded from the FSSA website, Candlewood Yacht Club website; cycsail.org, or may be completed at the regatta site. Sailing Instructions and Notice of Race will be available to registrants at the completion of registration.
- 4. Fees: The Regatta package includes continental breakfast and lunch on Saturday and Sunday, and dinner on Saturday evening for the skipper and one crew. Fees are \$95.00 per boat until August 20<sup>th</sup>. We encourage you to join US Sailing by going to home.ussailing.org, or by calling (800) 877-2451. Late fee for registration after August 20<sup>th</sup>: \$10.00. Additional regatta shirts and meals may be ordered on the entry form, and regatta shirts may also be available for purchase at registration, depending on supply. There is a \$5.00 discount for US Sailing members.

## 5. <u>Schedule</u>

Check-in and Late Registration: 4:00 - 6:00 PM Friday, August 28<sup>th</sup> and on 8:30 - 10:00 AM Saturday, August 29<sup>th</sup>.

Friday, August 28<sup>th</sup>, 6:30 - 9:00 PM Post-registration Boat Launch and Happy Hour Saturday, August 29<sup>th</sup>.

8:30 - 10:00 AM Continental breakfast,

10:00 AM Competitors' meeting,

11:00 AM Warning signal for first race, scheduled races may follow. No race shall start after 4:00 PM

6:30 - ? PM Dinner

Sunday, August 30<sup>th</sup>.

9:00 AM Continental breakfast

11:00 AM Warning signal for first race, additional races may follow.

No race shall start after 1:00 PM. Lunch and awards to follow.

6. <u>Measurement</u>: Boats and sails must conform to the Official Plan and Specifications. Each boat must carry equipment required by FSSA Specification Article S-V.2.

- 7. Courses to be sailed: The courses to be sailed will be as described in the Sailing Instructions.
- 8. **Berthing:** Boats shall be kept in their assigned places.
- 9. **Scoring:** The low-point scoring system of RRS Appendix A2 will be used, except that there will be no throw-outs. (Changes Appendix A2) Five (5) races are scheduled, of which one (1) must be completed to constitute a series.
- 10. <u>Prizes</u>: Prizes will be awarded to the top five boats in the Regatta. The Greater New York District Trophy will be awarded to the top finishing boat that is skippered by a FSSA member in the Greater New York District. The Jack Orr Trophy will be awarded to the sailor with the most first places in the Regatta. The Roger Punzi Memorial Trophy will be awarded to the top finisher. Non-FSSA members are not eligible for any prizes per FSSA Bylaws, **B-VII.2**

- 12. <u>Additional information</u>: No camping is permitted at the club's property. Also, the club is located on a private road; please respect the speed limit in the area.
- <u>VHF Policy</u>: FSSA rules permit carrying a VHF radio aboard at all times. As provided by the FSSA Specification ARTICLE S-V.7 competitors may monitor VHF Channel 68 in order to receive information from the Race Committee.
