

## Coconut Grove Sailing Club 2016 Annual One Design Regatta NOTICE OF RACE

**Sailing Instructions.** Racing will be governed by the *rules* as defined in *The Racing Rules of Sailing (RRS) 2013-2016*, except as modified and supplemented by the Biscayne Bay Yacht Racing Association Notice of Race and Sailing Instructions 2016-17, General Conditions and Sailing Instructions, Part II – Sailing Instructions: One Designs (available at www.bbyra.net). No separate Sailing Instructions will be issued. Protests shall be delivered to Protest Desk within 1 hour after the race committee Signal Boat docks. The protest time limit and a list of protests received will be posted on the notice board. Hearings will be held as soon as practicable after racing in the protest hearing room. This changes BBYRA 15.1 and 15.2.

**Registration.** You are cordially invited to join us for the Coconut Grove Sailing Club's 2016 Annual One Design Regatta. BBYRA registered One Design boats are already registered. The Registration Form on the following page is required for boats that are **not** registered with BBYRA. The Registration Form is due by 6:00 PM on Friday, September 30<sup>th</sup> to the CGSC office. One-Design boats from fleets other than South Florida fleets may submit their forms up until 9:00 AM on Saturday, October 1<sup>st</sup> to the Race Committee on the ground floor of the CGSC clubhouse.

**One Design boats** will race two days on **Saturday**, **October 1 and Sunday**, **October 2**. We are expecting entries in the Etchells, J24s/Sonars, Snipe, Flying Scot, Laser and Sunfish classes. Flying Scots will also be sailing for the Sally Russell Trophy and the Charlie Fowler Trophy. Snipes will be sailing for the Gonzalo "Old Man" Diaz Trophy. Six races are scheduled with no more than four in a day, weather permitting (this changes BBYRA 8.2).

PLEASE NOTE: Sunday's One-Design First Warning Signal is at **10:30 AM** (this changes BBYRA 8.1). Further, each boat's worst score will be excluded if six races are completed (this changes BBYRA S2.1). Otherwise, all races will be scored. This changes RRS Appendix A2 and BBYRA General Conditions and Sailing Instructions for 2016-17.

### GENERAL INFORMATION APPLICABLE TO ALL ONE DESIGN CLASSES

- There is no entry fee.
- On race day, each boat must check-in by sailing past the stern of the Race Committee boat on starboard tack prior to the warning signal of the first race in which it will be competing. No check-ins will be accepted during a starting sequence.
- <u>CGSC parking is limited to Members only</u>. Parking is available around the circle (metered) or at the Public
  Parking Garage next to the Sonesta for a discount with a CGSC stamp on your parking ticket. Class boats
  and trailers may be stored in the boat storage areas.
- Two electric hoists are available at CGSC. A public boat ramp is located adjacent to the Club property. Two
  floating docks are available at the Club.
