1. **Rules:** This regatta will be governed by the *rules* as defined by the current edition of the Racing Rules of Sailing (RRS).
2. **Eligibility:** All Flying Scot Sailboats that are FSSA Members are eligible.
3. **Registration** may be by mail using the attached form. Late registration may be completed at the regatta site beginning June 11, 2022 at 9 AM. Competitors may choose from Championship or Challenger Division (2 divisions will be sailed if 10 or more boats are registered.) Sailing Instructions and will be available to registrants at the completion of registration.
4. **Fees:** See Registration Form
5. **Schedule:**
 - 8:30 AM Continental Breakfast and Registration
 - 10:00 AM Skippers Meeting
 - 11:00 AM First Warning Signal
 - 4:00 PM Last Possible Warning SignalAwards and Late Lunch will be held after racing.
6. **Measurement:** Boats and sails must conform to the Official Plan. Each boat must carry equipment required by FSSA Specification Article S-V.2 (Racing Restrictions), and US Coast Guard requirements
7. **Courses to be Sailed:** The courses to be sailed will be described in the Sailing Instructions.
8. **Dry Berthing:** Boats shall be kept on trailers in parking area.
9. **VHF Radios:** It is the intention of the Race Committee to utilize VHF communication in accordance with FSSA Specification S-V-7.
10. **Scoring:** The low-point scoring system of RRS Appendix A2 will be used, except that there will be no throw-outs. 4 races are scheduled, of which one must be completed to constitute a series.
11. **Prizes:** Prizes will be awarded to the top 3 boats in the Championship Division, and to the top 3 boats in Challenger Division, The George Balas Trophy will be awarded for First Place in the Championship Division.
