\_\_\_\_\_ ACTIVE MEMBER (*Option to receive Scots n' Water electronically only*) \$60.

F/S owner, or bona fide part owner registered with the FSSA.

\_\_\_\_\_ ASSOCIATE MEMBER \$55.

Non-owner who has been a crew on a specific F/S with respect to which some person is an Active Member. Wife/husband/child of an ACTIVE member; or part-owners of such F/S provided that at least one part owner shall be an Active member.

\_\_\_\_\_ FAMILY MEMBER \$80.

\_\_\_\_\_ FAMILY MEMBER (*Option to receive Scots n' Water electronically only*) \$75.

Combination of one ACTIVE member and unlimited ASSOCIATE members who are all members of the ACTIVE member's immediate family and are under the age of 21 and are residing at the same address. There is one vote per FAMILY membership and only one member of the family may hold office. The ACTIVE member is the only member to get FSSA mailings with this classification.

\_\_\_\_\_ SUSTAINING MEMBER \$65.

Non-owners of F/S who have an interest in the Class.

\_\_\_\_\_ SPONSORING MEMBER \$75.

Company or individual who provides products and/or services to the membership or who has a special interest in FSSA.

\_\_\_\_\_ LIFE MEMBER

LIFE members have the same privileges and qualifying criteria as an ACTIVE member.

Requirement for dues, in lieu of annual payment, is a one-time donation of \$1,000.

\_\_\_\_\_ CLUB REGISTRATION ONLY \$45.

This category is **ONLY** for recognized Clubs/Associations to register their owned F/S

\_\_\_\_\_ CLUB MEMBER \$65.

A non-owner individual belonging to a recognized Club/Association which owns and has registered the boat # listed above.

\_\_\_\_\_ JUNIOR MEMBER \$32.50

A person under the age of 19 who is a non-owner of a F/S.

\_\_\_\_\_ TRANSFER OF OWNER \$10.

Transfer of record and reissuance of registration certificate decided for purchasers of used F/S sloops.
