#### 1. Venue

Cedar Point Yacht Club at 1 Bluff Point, Westport, CT and the waters of the Long Island Sound off Westport, CT. Boats shall be launched by hoist from the drystall. Parking for car and trailer are on-site.

#### 2. Rules

This regatta will be governed by the rules as defined in The Racing Rules of Sailing (RRS), the FSSA Class Rules and the Sailing Instructions.

## 3. Eligibility

The regatta is open to any dues paying member of a Connecticut Flying Scot fleet. The helmsman shall sail the same boat and shall be scored the first two races. Additional races shall not count for Connecticut Cup standings.

## 4. Entry

Eligible participants may enter by completing an entry form, registering and checking in at CPYC. Registration shall be completed by either **(A)** email to Chris Perez as shown in 13 below by 5 PM on Saturday, July 14, with names of skipper and crew, sail #, email address of skipper and club affiliation of skipper, or **(B)** by registering at CPYC Governor's Room on Sunday from 1000 to 1200.

#### 5. Fees

There is no entry fee for this program.

#### 6. Schedule

## Sunday, July 15

0900 – 1100: Registration, open.

1245 Warning signal for the first race.

Additional races may follow. 1800 BBQ

## 7. Sailing Instructions

Sailing Instructions will be distributed via email on request.

### 8. Courses

The courses to be sailed will be described in the Sailing Instructions. As a minimum, a Windward-Leeward course will be included.

## 9. Scoring

The low-point scoring system of RRS Appendix A2 will be used, except that no score shall be excluded. This modifies RRS A2.1. One race constitutes a regatta.

### 10.Prizes

Prizes for the Connecticut Cup shall be awarded on another date upon completion of all 3 legs. Prizes will be awarded to the top three competitors of the day.

## 11. Disclaimer of Liability

Competitors participate in the regatta entirely at their own risk. See RRS 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

#### 12. Directions and Facilities

## To CPYC (from North or South) -

Connecticut Turnpike (I-95) to exit 17 (Westport). At the end of the ramp, turn right onto Route 136. Go about 1.5 miles on Route 136. Turn left on Duck Pond Road. Take your first left on Harbor Road. Follow Harbor Road to the stop sign before single lane wooden bridge, which is under construction. Turn right. Follow signs to CPYC. Drive slowly and be aware of the many speed bumps.
