## Ewings Win Wife-Husband National Championship at Lake Carlyle


ouples traveled from Alabama, Texas, Wisconsin, New Jersey, Pennsylvania, Maryland and the Midwest to enjoy pleasant breezes, camaraderie, friendship, wonderful food, and fun at Carlyle Sailing Association. Twenty-eight Flying Scot couples competed, evenly divided in two divisions on June 19 and 20. On Saturday three races were completed in nice light winds of 6 to 12 miles per hour. A nice breeze early Sunday morning, that totally died 15 minutes into the race, caused abandonment "I used an RC prerogative to abandon because it became no longer a test of skill" as stated by Principal Race Officer, Ted Beier (US Sailing Senior Judge).

The first race, a windward-leeward with a gate, began with the Championship Division reaching the first mark with an easterly breeze of 6-8 mph. The fleet was led by Bill and Eileen Ewing (New Jersey), than Susie and Tim Stombaugh (Ohio), John and Suzie Domagala (Indiana), Jerry and Sunshine Hartman (Pensacola), and Jim and Betty (Struckhoff) Harris (Carlyle). Positions continued to change throughout the runs and the second beat. At the leeward mark, Harris was at the tail of Ewing rounding the starboard gate mark. In sixth place, Hartman was first to see the 30 degree windshift to the north and was the first to round the port leeward gate to find himself finishing behind the Ewings and Paul and Denise Lee (Detroit) for a third place finish. All couples were photographed by me with a digital camera with spinnakers flying. New borrowed "toys" are wonderful.

Into the sequence of race two another windshift came, RC postponed with a reset to the southeast breeze of 7 - 10 mph. Prior to the lunch break, finishing first were the Ewings, followed by Scot and Natalie Mauney (Dallas) in second, and the

Lees in third. After lunch an Olympic Modified race was sailed with winds beginning at 8 mph changing from 110 degrees to 130 degrees for another postponement. The winds increased to 10 -12 mph and the longest race was finished on a beat with a change to 100 degrees. In the third race the Ewings guaranteed their regatta win with another first and the Lees almost insured their second with a second. John and Patti Applegate (New Jersey) placed third.

Sunday morning the race was begun in a nice breeze of 5 - 6 mph after a postponement again with windshifts from the 120 degree, to 140, to 160, to 90 degrees and then, and then fifteen minutes after the start, abandonment, and we again had a windless Sunday. (CSA has now had three windless Sundays in a row during June.)

The Challenger fleet found rotating finishes with two DSQs from couples who won a race. So, with two seconds and a fifth, Brian and Laura Bolin (Georgia) won the Challenger Division. Winning the third race pink spinnaker Jim and Myra Brown (Chattanooga) won second place. Third and fourth place were won by locals Mike and JoeAnn Sullivan and Joe and Marilyn Gerrity. Bill and Carol Clark won their first regatta trophy by placing seventh with their new sails. Fleet #83 is looking forward to Bill and Carol shining in their new Scot #5170. The Gerrity's received two special award for the oldest couple (151) years as well as the longest married (55 years). Each first seven couples in each division received a clock for their trophy.



## 1999 Flying Scot North Americans July 25 - 30, 1999 • Gulfport Yacht Club, MS

John Dane III added the Flying Scot North American Championship to an already impressive list of sailing accomplishments, including the Sears Cup, the Soling North American Championship, and the L-16 International Championship. He outdistanced Greg Fisher of Columbus, Ohio, a perennial Flying Scot favorite, in what turned out to be a twoboat series. In the first two races of the series, Dane posted back-to-back second place finishes, while Fisher's fourth and first place finishes put him one point behind. On the second day, the breeze freshened to Dane's liking, and he scored two impressive victories. "We had two windy races today, which are our best conditions," he said in an obvious understatement. In any case, his grip on the championship tightened dramatically

after the two wins. Going into the last race, only Fisher was within striking distance. "My strategy was to stay close to Fisher," Dane said. "We actually got a better start than he did. So on the first tack we were ahead of him and basically covered him the rest of the way." Dane finished third to Fisher's sixth, with Benz Faget of New Orleans second in the final race and third overall in the regatta.

Though these were, in effect, home waters for John Dane, it was outstanding boat speed and impressive crew work that won the day. "We had good boat speed throughout the series...and the crew work on the spinnaker runs was great." he said. His crew consisted of son Schaeffer Dane and Leslie Kelly, herself a three-time Women's North American Sunfish Champion. "Leslie was taken care

of," Dane said, adding, "My son is big and strong and he handled the front. We had good teamwork." In addition to Dane and Fisher, other individual race winners in the series were Doc Bellows who won the first race and Bruce Lindheim who won the final race.

In the Challenger Division, Anton Speaker of host Gulfport Yacht Club, after finishing eighth in the first race, won four straight to capture that series. Schaeffer Dane, who crewed for his father in the Championship Series, won the Junior Championship, while Shelly Killeen won all three races to capture the Women's Championship. It is interesting to note that John Dane, Schaeffer Dane and Shelly Killeen all hail from Pass Christian Yacht Club - quite an accomplishment for one sailing club.

## 1999 NAC Board of Governors Meeting

In order to keep our membership well-informed, we are reporting the results of our Board of Governors' meetings. Here is the report of the 1999 meeting held July 26, 1999, at Gulfport Yacht Club.

**Minutes** - The minutes from the 1999 Mid-Winters Meeting were approved as written.

Budget and Membership - FSSA Headquarters Staff (Crews and Brunson) reported that dues income is down, and membership is down by about 100. There are currently about 1800 members. McClurkin (Treasurer) and discussed the billing cycle prior to the meeting. Staff recommended that dues renewals not be changed from the current August date, but that second notices be sent in February. Also, the dues notice printing will be done in-house, because the one-time cost of conversion is expected to be outweighed by the overall cost savings. This will be evaluated after two years. All agreed. The following additional actions were agreed upon to decrease cost and increase membership:

- 1. The November-December issue of *Scots n Water* will contain a statement to the effect that this will be your last issue if you have not renewed. The Electronic Media chair will implement a method (if possible) for paying dues via e-mail through the Web Site.
- 2. Staff will prepare a letter for the President's signature explaining the benefits of membership, and will send this letter with the second dues notice. To support this effort, the immediate Past Commodore will provide to Staff a similar letter he had previously prepared.
- 3. The same letter will be sent to the Fleet Captains along with the annual letter they get with the list of renew-

ing and non-renewing members. The letter which forwards this list will request the Fleet Captains to contact the non-renewers and remind them of the benefits of membership.

4. Dues renewal notices will be sent to members during the last five years, rather than to the entire database of 4000 previous owners.

Whether to grant a one-year free membership to new owners was discussed. All agreed that this should be the subject of a Development Committee recommendation at the next meeting.

The 1999-2000 budget was approved as proposed. It shows a slight deficit due to the one-time cost for issuing the new Handbook, discussed below, which is offset by the surplus from previous years from funds budgeted for the Handbook but not spent.

District Governors were requested to strictly enforce the requirement that in order to sail in a District or Regional Championship, you must be a member, Staff will provide each District Governor with membership forms so that nonmembers can join on-the-spot the day of a District or Regional Regatta.

**Executive Committee** - Goldberg reported that in response to a written request for a clarification of the Constitution, the Executive Committee ruled that membership in a Yacht Club cannot be a requirement for membership in a Fleet. The President will prepare a letter with this ruling to the fleet involved, with a copy to the letter author, for the Staff to issue.

Measurer - Neff (via Carpenter) reported that Gulfport Yacht Club did an outstanding job of measurement and no problems with boards or hulls were encountered. A list of new Chief Measurer's rulings was recommended, consisting of minor clarifications and "clean-up" as opposed to major changes. These were approved with an editorial

change to item #1 to add "is permitted." They will be incorporated into the Handbook prior to issue.

International Race Committee -Harris reported no problems. Goldberg thanked Harris for ensuring that the NAC Sailing Instructions conformed to the Standardized SIs, and noted that the IRC chairs in the future must be diligent in informing the NAC (and Mid-Winter) host clubs that the IRC chair must review and approve proposed SIs, and must be diligent in ensuring that they conform to the Standardized SIs, particularly with regard to course diagrams. In response to a request from the Judges of the 1999 Juniors, Harris recommended that the Standardized SIs be revised to prohibit the presence of adult competitors in protest hearings for Juniors. This was approved with a minor clarification to define "Juniors" per the FSSA eligibility criteria, and will be included in the Standardized SIs prior to issue of the Handbook. Also, the standardized SIs will be e-mailed to the Staff for inclusion on the Web Site. The standardized Notice of Regatta and Host Club Questionnaire will also be posted on the Web Site.

Scots N Water - No report. Goldberg congratulated Jack Rudy (Ohio District Governor, but not present) for a new World Record - six articles in the July/August 1999 edition! Brunson mentioned that she received an article for S n W from Israel. Gulfport Yacht Club was requested to write an article for Sailing World on the FS NACs, and will be requested to forward this article to Hartman for S n W.

**Publicity and Development** - No report. Goldberg stated that Bill Ross is the PRO for the Thistle Nationals this week, and is scouting their site (Elizabeth City, NC) as a potential location for a future FS NAC. Brunson stated that there

is a new fleet in Utah and that two fleets were withdrawn from the suspension list and will remain active.

Amendments - Because of conflicting interpretations in the past, Goldberg proposed and the Board approved a By-Law change to state that in order to win a District Championship, one must be a member of that District. This will be incorporated into the Handbook prior to issue. Taggart reported that previously approved changes, inadvertently overlooked in the previous draft, have all been incorporated in the new electronic version.

**Handbook** - Brunson reported that Neff has completed the conversion of the Official Plan to an electronic format and has forwarded it to Staff. This will be on one-page fold-out that will replace 11 pages of current text. Taggart reported that the conversion from a typeset hard-copy to electronic format is complete, and that the new revision will be ready to issue after incorporation of the changes

approved at this meeting. Taggart will e-mail the final clean copy to Staff by August 15, 1999. Various options were discussed for disseminating the information in the new Handbook, considering the large printing and postage expense. The following plan was agreed upon:

- 1. The revised Handbook will be posted on the Web Site.
- 2. All new members will receive a binder with hardcopy.
- 3. Any old member who wishes to receive a hardcopy can receive one (free) upon request to FSSA Headquarters, excluding the Official Plan.
- 4. The Official Plan will be sold for \$5.00, because of the large expense to print it (special paper material and non-standard size).

Taggart will send an article to *Scots n Water* describing the new Handbook, its division into two parts and their contents, and the options for obtaining a copy as described above.

Staff will print an appropriate number of hardcopies after review of pricing

options with Goldberg. Crews stated that the new version can be posted on the Web Site and hardcopies can be printed within two weeks after receipt of the final clean copy from Taggart. Brunson stated that advertisers have been slow in responding to solicitations for advertising in the Handbook. Fowler (Florida District Governor) noted that cost is somewhat high. Goldberg requested Staff to aggressively follow-up with advertisers so as not to delay the issue of the new revision. It was also requested that our advertisers be linked to the Web Site. This will be investigated.

Goldberg noted that the one section of the Handbook, on guidance/protocol for running a NAC, has not been updated as part of the current revision. Harris agreed to draft an update with input from the current Gulfport Yacht Club NAC regatta chairman.

**Electronic Media** - Jacobsen reported that the Web Site is much improved since its overhaul by Hank Sykes earlier this year. He requested and Staff agreed that District and Regional

events should be posted in the same manner as NACs, Mid-Winters, and Wife-Husband (i.e., immediately upon receipt). He also requested that District Governors encourage their local and fleet-level regatta chairs to e-mail results to Headquarters, and to advise him of any changes needed to the Web Site. Jacobsen also reported that the standard regatta announcement form had been created and he will e-mail it to Staff to be posted on the Web Site in a "fill-in-theblank." In order to ensure that the Web Site is accurate and current, Goldberg requested and Jacobsen agreed that he would contact Courtney at Staff on a monthly basis regarding additions, deletions, changes, etc.

Caveat Emptor on the Web Site – Jacobsen recommended that the Caveat Emptor page be restored to the Web Site in a modified manner. The boat information would be listed with the actual listing date, without owner name or phone or email address, and promptly removed after 60 days, for a \$40 fee. All inquires from

prospective buyers would be through the FSSA Headquarters, to ensure they are aware of the FSSA and the benefits of membership. This recommendation was approved. Staff will revise the Web Site accordingly and announce the fee structure in *Scots n Water* and on the Web Site. Jacobsen will advise Courtney of Staff when to delete each listing (after 60 days). Staff will retain the "Hot List."

Future Regattas - Staff has received a copy of the permit Indian Harbor has been waiting for and will formally advise Josh Goldman that they are granted the 2000 NAC. The 2000 Wife-Husband was granted to Saratoga. Staff will advise Ann Seidman. No formal bids have been received for the 2001 NAC although Tom's River previously expressed an interest. Jacobsen will contact them to determine their interest for 2001 or 2002 and advise Goldberg. Beery (Capitol District Governor) will explore options in his District. Goldberg will contact Ross regarding Elizabeth City, NC. Berlin Lake has expressed interest in the 2001 WifeHusband. Stombaugh (acting for Rudy) will request Rudy to request them to send a formal bid to Headquarters.

The Board approved the Executive Committee as Dan Goldberg, Terry Dees-Kolenich, Jim Harris, Jack McClurkin and Larry Taggart.

The meeting was then adjourned.




**Award Ceremony** - A plaque was presented to Daniel Goldberg from Peter Christian and the Gulfport Yacht Club. Also the class burgee was given to the

## How I Spent My Spring Break


The time had come. I knew that the bottom paint on *Jollymon* had to come off. We were sailing fast, but deep inside I felt that those coats of bottom paint were slowing us down.

I had used a chemical stripper to take the bottom paint off the centerboard when I had it out for a repair to the leading edge and I knew it worked well. I wanted to use the same method for the bottom. The stripper I used, Evercoat One-Step from The Fiberglass-Evercoat company was great. It

didn't damage the gelcoat and took the blue bottom paint off with a lot less work than sanding.

I had some remover left over from the earlier centerboard job and started to search for more. After a couple of calls with no luck, I called the manufacturer., I found that it was no longer being manufactured, probably for environmental/health/EPA reasons (ie, it really works well!). On a chance I called West Marine with a 1997 catalog part number and they had it. I immediately ordered three gallons.

Finding a place to do this work was difficult. A local boat dealer, Sunset Sailboats, helped out. Thanks Todd! My plan was to put up the mast, slide the boat off the trailer and then use the main halyard and plenty of friends to put *Jollymon* on its side. I had been advised to put a car tire under the side where the chainplate attaches to the shroud. This was excellent advice. The trailer came out from underneath the boat and with a lot of effort and coordination our Scot was on its side. The top of the mast was held down with a concrete block and tied lines to various parts of the hull to keep it over on its side.




Even though I worked in very windy conditions, I always wore a respirator when working with this stripper. There must be a number of reasons why it is no longer being manufactured.

My technique went like this: paint a three foot by three foot section with the stripper, wait approximately ten to fifteen minutes and then take a plastic putty knife and scrape off all the bottom paint that would come off. *Jollymon* had five coats, one coat for every two years that the original owner had it on the bay in Stone

Harbor, NJ. After the first removal, I repeated the process with the scraper. It took three coatings and scrapings to get down to the white bottom. At that point the process changed and I dipped coarse synthetic steel wool into the stripper and scrubbed the bottom. That loosened more so I could scrape again. The final steps were using the synthetic steel wool and then wiping the residual amount off with a wet sponge. I used heavy gloves, and even a chemically resistant glove was eaten up by this stuff!

You realize how much surface area the Scot has with the water and after six treatments with stripper, scrapers, synthetic wool and sponges, the bottom was clean and smooth. I have never had to wet sand or touch the gelcoat in any way. While the boat was on its side, I replaced the centerboard gasket. The directions from Flying Scot, Inc. are excellent on how to complete that job.

Jollymon now has no excuses for being slow on the course. Although there is no way to know if we're really faster now than before - I believe that the time and energy was well spent. It's all in the mind of the sailor.
